

APPROVING A TIME EXTENSION FOR THE
SOUTH MAUI COMMUNITY PLAN ADVISORY
COMMITTEE TO SUBMIT RECOMMENDED
REVISIONS TO THE PLANNING DIRECTOR'S
DECENNIAL REVISIONS TO THE KĪHEI-
MĀKENA COMMUNITY PLAN

WHEREAS, the Planning Director transmitted to the South Maui Community Plan Advisory Committee decennial revisions to the Kīhei-Mākena Community Plan under Section 2.80.090(A), Maui County Code, including a proposal to rename the Kīhei-Mākena Community Plan Area to the South Maui Community Plan Area; and

WHEREAS, under Section 2.80B.080(E), Maui County Code, a community plan advisory committee must submit recommended revisions to the Planning Director within 180 days of its first meeting, unless the Council grants a time extension by the resolution; and

WHEREAS, the South Maui Community Plan Advisory Committee held its first public meeting on October 19, 2022, and, without a time extension, is required to submit recommended revisions to the Planning Director by April 17, 2023; and

WHEREAS, by County Communication 79-23, dated March 10, 2023, the Acting Planning Director advised that the South Maui Community Plan Advisory Committee requested a time extension; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That the South Maui Community Plan Advisory Committee is granted a time extension until October 17, 2023, to submit recommended revisions to the Planning Director's decennial revisions to the Kīhei-Mākena Community Plan, under Section 2.80B.080(E), Maui County Code; and
